

END USER LICENSE AGREEMENT (EULA)

Black Arts Techs Plugins, sample data and documentation

This EULA sets forth the terms and conditions under which Black Arts Techs (“Licensor”) grants the end user (“Licensee”) the right to use the software plugin(s) (“Product”).

By installing or using the Product, the Licensee agrees to be bound by this EULA.

1. License Grant

The Licensor grants the Licensee a non-exclusive, non-transferable license to use the Product for music production and audio processing purposes.

2. Permitted Uses

- The Licensee may create, publish, and sell musical works, sound design, and audiovisual content produced with the Product for commercial and non-commercial purposes.
- The Product may be installed on multiple computers owned or controlled by the Licensee, provided that simultaneous use is limited to the Licensee.
- However, use that violates laws or public order and morals is prohibited.

3. Restrictions

- Redistribution, resale, lending, transfer, or shared use of the Product is prohibited.
- Reverse engineering, decompiling, modifying, or otherwise attempting to derive the source is prohibited.

- Sharing or unauthorized use of license keys/serial numbers is prohibited.
- Any act that enables third parties to misuse the Product is prohibited.

4. Ownership

All intellectual property rights in and to the Product are owned by Black Arts Techs. The Licensee acquires no ownership rights to the Product, only a license to use it under this EULA.

5. Disclaimer of Warranties; Limitation of Liability

THE PRODUCT IS PROVIDED “AS IS” WITHOUT WARRANTIES OF ANY KIND, EXPRESS OR IMPLIED, INCLUDING BUT NOT LIMITED TO MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, AND NON-INFRINGEMENT. IN NO EVENT SHALL THE LICENSOR BE LIABLE FOR ANY DIRECT, INDIRECT, INCIDENTAL, CONSEQUENTIAL, OR SPECIAL DAMAGES ARISING OUT OF OR IN CONNECTION WITH THE USE OR INABILITY TO USE THE PRODUCT. The Licensor has no obligation to provide updates or support.

6. Termination

This license shall terminate automatically if the Licensee breaches any term of this EULA.

Upon termination, the Licensee must cease all use of the Product and uninstall it.

7. Governing Law and Jurisdiction

This EULA shall be governed by and construed in accordance with the laws of Japan.

Any disputes arising out of or related to this EULA shall be subject to the exclusive jurisdiction of the Tokyo District Court as the court of first instance.
